1.	Candidates should have passed Degree / Diploma in respective branch / discipline
2.	Those who have already attended the apprenticeship training elsewhere will not be considered.
3.	Wherever CGPA/ OGPA or letter grade is awarded; equivalent percentage of marks should be indicated in the online application form as per norms adopted by the University/Institute. Candidates would be required to produce CGPA to Percentage conversion formula of their Institute/University at the time of document verification.
4.	The engagement and training are strictly in compliance with the provisions of the Apprentices Act 1961 and 1973 (as amended from time to time) and Apprenticeship Rules 1992.
5.	Name and Date of Birth as recorded in the Birth Certificate / Secondary School Leaving Certificate (SSLC)/ Matriculation / Secondary School Certificate shall be the only acceptable document in support of proof of age.
6.	The list of selected candidates will be displayed on GPCB website.
7.	Accommodation and Transport facility will not be provided to apprentices during the apprenticeship period. The apprentices shall make their own arrangement for accommodation and conveyance.
8.	No TA/DA will be paid for attending physical verification of documents or at the time of commencement of the apprenticeship.
9.	At any stage of the selection process, if it is found that the candidate has furnished false or incorrect information, the candidature of the candidate will be cancelled.
10.	Incorrect / Incomplete applications will be summarily rejected. No correspondence will be entertained with the candidates.
11.	GPCB will carry out all correspondence through email only and no postal correspondence will be sent.
12.	Candidates are advised to regularly visit the Institute's website for getting the information about the apprenticeship training.
13.	The apprentice after completion of the training shall have no right to claim any employment In GPCB.
